
Terms and Conditions:

- d. All related expenses of the travel will be borne by himself;
- e. Travelling expenses will have to be shown in the income tax return;
- f. The Provision of Rule 34 of Appendix VIII of BSR (Part-1) is applicable in this regard. That is to say, the officer has to start his leave within the 35 (thirty Five) days from the date of this order as this order will not remain in force after the 35 (thirty five) days from the making thereof and
- g. Granted Leave is non-cancelable.

2. The order issued in the memorandum No. 37.00.0000.069.08.003.23.4 dated 10 January, 2024 of the Secondary and Higher Education Division shall be deemed cancelled.
