

- i) All the expenses of the above mentioned officials related to Air-ticket, Accommodation, Food and all kinds of transportation will be covered by the organizer (China Education Informatization Industry Technology Innovation strategic Alliance).
 - ii) In case of official Sl. No. 1 (one), 30% pocket allowance and 25% transit allowance will be borne from the concerned fund of the Secondary and Higher Education Division. In case of official Sl. No. 2 (two), 30% pocket allowance and 25% transit allowance will be borne from the concerned fund of the Bangladesh Bureau of Educational Information and Statistics. In case of official Sl. No. 3 (three), 30% pocket allowance and 25% transit allowance will be borne from the concerned fund of the Directorate of Secondary and Higher Education.
 - iii) They will not be provided any part of their salary and allowances in foreign currency;
 - iv) The period of their stay in abroad including transit will be treated as on duty;
 - v) They will not be allowed to stay in abroad more than the approved period;
 - vi) They will have to submit a report to the Secondary and Higher Education Division, Ministry of Education within 15 (fifteen) days of their return.


